## LOCAL LAW OF 2019

# AMENDING LOCAL LAW NO. 1 OF 2010, ENTITLED "ENACT A VETERANS TAX EXEMPTION PURSUANT TO SECTION 458-B OF THE REAL PROPERTY TAX LAW FOR QUALIFIED RESIDENTS OF THE TOWN OF CORTLANDVILLE"

A Public Hearing was held by the Town Board of the Town of Cortlandville at the Raymond G. Thorpe Municipal Building, 3577 Terrace Road, Cortland, New York, concerning the enactment of a Local Law to Amend Local Law No. 1 of 2010, entitled "Enact Veterans Tax Exemption Pursuant to Section 458-b of the Real Property Tax Law for Qualified Residents of the Town of Cortlandville."

Supervisor Tupper called the Public Hearing to order.

Town Clerk, Kristin Rocco-Petrella read aloud the published, posted and filed legal notice.

Supervisor Tupper offered privilege of the floor to those in attendance.

No requests were made for privilege of the floor. Supervisor Tupper explained that prior to the Cold War Veterans tax exemption, the federal government gave exemptions to veterans based on their dates of service during times of war. If a veteran did not serve during a time of war, the veteran was not entitled to an exemption. Local Law No. 1 of 2010 provided for such exemption in accordance with the law, however at the time it was approved there was a 10-year sunset provision. The federal government has since eliminated the 10-year expiration, which resulted in the need to amend the local law.

No further comments or discussion were heard.

The Public Hearing was closed at 5:05 p.m.

WHEREAS, a resolution was duly adopted by the Town Board of the Town of Cortlandville for a public hearing to be held by said Board to hear all interested parties on a proposed Local Law amending Local Law No. 1 of 2010, entitled "Enact a Veterans Tax Exemption Pursuant to Section 458-b of the Real Property Tax Law for Qualified Residents of the Town of Cortlandville", and

WHEREAS, notice of said public hearing was duly published in the *Cortland Standard*, the official newspaper of the said Town, and posted at the Raymond G. Thorpe Municipal Building, 3577 Terrace Road, Cortland, New York, as required by law, and

WHEREAS, said public hearing was duly held and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed Local Law, or any part thereof, and

WHEREAS, the Town Board of the Town of Cortlandville, after due deliberation, finds it in the best interest of the Town to adopt said Local Law,

NOW, THEREFORE, the Town Board of the Town of Cortlandville hereby adopts said Local Law as Local Law No. 1 of 2019, amending Local Law No. 1 of 2010 in manner following, and the Town Clerk is directed to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Town of Cortlandville, and to give due notice of the adoption of said Local Law to the Secretary of State.

Be it enacted by the Town Board of the Town of Cortlandville as follows:

Section 1:

Section 2 of Local Law No. 1 of 2010 is amended by adding a subparagraph thereto as follows:

2a. Pursuant to subsection 2(a)(iii) of Section 458-b of the NYS Real Property Tax Law, the exemption heretofore authorized shall apply to qualifying owners of qualifying real property for as long as they remain qualifying owners, without regard to any ten year limitation.

#### Section 2:

This Local Law shall take effect immediately upon its filing with the Secretary of State and shall be applicable to all assessment rolls prepared pursuant to the first taxable status date occurring on or after the effective date of this local law.

Town Clerk Rocco-Petrella presented the Board with the January 2019 monthly report for Tax Collection and requested it be received and filed. She gave the Board a brief review of the month of January, in which over 78% of the total warrant was collected. The Town's budget was satisfied as was the Fire Department. She mentioned that of the four grass relevies only one remained unpaid at this time. She thanked her staff for their hard work throughout the busy month of January.

Councilman Withey made a motion, seconded by Councilman Testa, to receive and file the monthly report of the Tax Collector for the month of January. All voting aye, the motion was carried.

Town Clerk Rocco-Petrella apprised the Board the New York State Department of State will be conducting a training session at the County Office Building on March 11, 2019. Planning Board members and Zoning Board members will be attending. Topics to be covered are Intermunicipal Agreements; Planning and Zoning: An Introduction and Site Plan review. Town Clerk Rocco-Petrella provided Town Board members with the general information and requested they notify her if they wish to attend.

There was discussion regarding the Bill signed into law by Governor Cuomo regarding the extension of time for tax collection without penalty for furloughed federal employees. Attorney Folmer explained that he was waiting to hear from the County Attorney regarding the County's intent to act on the item before the Town Board took action. Town Clerk/Tax Collector Rocco-Petrella mentioned that penalties paid to her remain with the Town and are turned over to the Supervisor. She did not expect the legislation to impact the Town and was aware of only one property owner who inquired about the legislation.

Attorney Folmer reported:

Appointment of Town Attorney:

There was discussion regarding the appointment of a Town Attorney. Attorney Folmer recommended the Board implement their appointment by an appropriate resolution. Supervisor Tupper apprised those in attendance that many attorneys were approached to fill the position. Four applications were received and extensive interviews were conducted by Supervisor Tupper and Councilman Ross, who indicated that all four applicants were impressive. A decision was made to appoint John A. DelVecchio, Esq. effective March 1, 2019. Attorney Folmer expressed praise for the Board's choice and said through his observances he found Mr. DelVecchio to be an outstanding choice for Cortlandville Town Attorney. Supervisor Tupper thanked Councilman Ross for his diligence and expertise throughout the selection process.

Councilman Ross introduced a resolution to appoint John A. DelVecchio, Esq. as Town Attorney effective March 1, 2019 until January 1, 2020.
