TOWN BOARD MEETING

The Regular Meeting of the Town Board of the Town of Cortlandville was held at the McGraw Community Building in the Village of McGraw, McGraw, New York, with Supervisor Tupper presiding.

Others present were: Town Attorney, John Folmer; Highway Sup't. Carl Bush; Barb Leach; Village of McGraw Mayor, Allan Stauber; Heather Cobb from the Lamont Memorial Free Library and Tyrone Heppard from the Cortland Standard.

Supervisor Tupper called the meeting to order.

Councilman Proud made a motion, seconded by Councilman Rocco, to approve the Draft Town Board Minutes of April 1, 2015 as written. All voting aye, the motion was carried.

Councilman Leach made a motion, seconded by Councilman Testa, to receive and file the Cortlandville Planning Board Minutes of March 31, 2015. All voting aye, the motion was carried.

Supervisor Tupper offered privilege of the floor to Heather Cobb of the Lamont Memorial Free Library.

Heather Cobb, Library Director, thanked the Town for its continued support. She mentioned that the children's programs offered by the Library were doing well, however the new teen program struggling a little bit as there was not as much interest. The Library was beginning its monthly craft program for all ages, and was also gearing up for its summer reading programs, which run from the middle of June through July.

Councilman Rocco questioned whether the Library received cooperation from schools to increase participation. Ms. Cobb indicated that the Library submits its promotions to the schools.

Supervisor Tupper offered privilege of the floor to Allan Stauber, Village of McGraw Mayor.

Mayor Allan Stauber thanked the Town for their continued support and everything it does to help the Village. He mentioned that the Town contributed the entire cost of the sewer pump that the Village was in need of. He also thanked Highway Sup't. Bush for his help with road work in the Village.

Mayor Stauber discussed the Village Recreation Department and its programs and noted that Recreation Director, Cory Smith was not able to attend the meeting. The Village pool would be open this summer, but with limited hours due to difficulty finding lifeguards. He discussed the summer program schedule. Scholarships were available to help people participate in the programs, such as the soccer program. He mentioned other special events held in the Village such as its annual Easter Egg Hunt and Halloween Parade. Mayor Stauber thanked the Town for its generous donation which increased from last year.

Councilman Leach questioned whether the Memorial Parade would take place this year. Mayor Stauber indicated that there would be a Memorial service and a small parade this year.

Councilman Leach complimented the Village of McGraw for being a great community with a lot going on and available to the public, and complimented the number of volunteers in the Village. He also mentioned the Civil War cannons and how the cemetery is well kept.

Councilman Rocco questioned what the lifeguard qualifications were. Mayor Stauber explained that the individual needs the Red Cross lifeguard certification, which is valid for 2 years. The Village would cover the cost of the lifeguard certification at the end of the season (prorated). The Village also increased the salary for the lifeguards.

Councilman Leach shared a story about his son who bought a home in the Village of McGraw and recently drove his 1955 McCormick Tractor through the Village to watch a soccer game.

Councilman Proud made a motion, seconded by Councilman Leach, to receive and file correspondence from Time Warner Cable, dated May 6, 2015, regarding programming services. All voting aye, the motion was carried.

The monthly reports of the Town Supervisor, Town Clerk, Tax Collector, Water & Sewer Department and Code Enforcement Office for the month of April and the Cortland County SPCA for the month of March were on the table for review and are filed in the Town Clerk's office.

Supervisor Tupper apprised the Board that he received correspondence from the New York State Town Clerk's Association (NYSTCA) regarding the renewal of Town Clerk Snyder's Registered Municipal Clerk (RMC) certification for another five years. In order to obtain the recertification Town Clerk Snyder had to complete the required education/training. Supervisor Tupper also received notification that Deputy Town Clerk, Kristin Rocco-Petrella renewed her RMC as well. The Board applauded Town Clerk Snyder for her accomplishment.

Under new business, Town Clerk Snyder reported that she has been appointed through NYSTCA as the Chairman of the RMC (Registered Municipal Clerks) committee to review new and renewal RMC applications.

Water/Sewer Projects – SEQRA:

Attorney Folmer recalled that on April 1, 2015 the Board adopted a resolution declaring Oakcrest Street/Pendleton Street/Saunders Road Sanitary Sewer Improvement Project a Type II action under SEQRA. However, the Saunders Road Sanitary Sewer Improvement Project has been withdrawn from such project. Attorney Folmer suggested the Board rescind the resolution adopted April 1, 2015, and adopt a new resolution declaring Oakcrest Street/Pendleton Street Sanitary Sewer Improvement Project a Type II action under SEQRA.

Attorney Folmer reported that he was in contact with Bond Counsel in New York regarding the bonding for the projects. The SEQRA determinations would be sent to Bond Counsel, who would put together the orders calling for the public hearings. Attorney Folmer indicated that he may ask the Board to call a special meeting to adopt the orders calling for public hearings prior to the next Town Board Meeting. The amount to be bonded was \$965,000.

Local Law of 2015 – Zoning Law and Map Amendment for Suit-Kote Corp.:

Attorney Folmer requested the Board schedule a public hearing regarding the proposed Zoning Law and Map Amendment submitted by Suit-Kote Corporation. The County Planning Board recommended approval of the zone change.

Councilman Leach made a motion, seconded by Councilman Proud, to receive and file correspondence from Diana Graser, P.E., New York State Department of Transportation, dated April 30, 2015, notifying the Town that after a second review a reduction in speed limit for the full length of Ahrens Road from 55 mph to 45 mph was appropriate. All voting aye, the motion was carried.

Supervisor Tupper thanked Town Clerk Snyder, Highway Sup't. Bush, and the County Highway Department for their efforts with the reduced speed limit request. The Board was pleased that the NYS DOT's second review resulted in the approval of the Town's request for a reduced speed limit. Town Clerk Snyder reminded the Board that a third request was made to the NYS DOT and she hoped that the speed limit would be further reduced.

Supervisor Tupper questioned whether there was anything further to come before the Board.

Councilman Leach mentioned that while attending the last McGraw girl's softball game he saw a bald eagle flying around. He wondered if Mayor Stauber knew whether there was a nest nearby. Mayor Stauber was not aware of a nest, but the bald eagle had been spotted on numerous occasions perched in a tree near the soccer fields.

No further comments or discussion were heard.

Councilman Leach made a motion, seconded by Councilman Proud, to adjourn the Regular Meeting. All voting aye, the motion was carried.

The meeting was adjourned at 5:35 p.m.
