

TOWN OF CORTLANDVILLE - HIGHWAY PERMIT # _____

WHEREAS, a certain highway known as _____ has been improved and is on the Town of Cortlandville road system. Working at tax map number _____

NOW, THEREFORE, permission is hereby granted to said (applicant) _____

To do said work with the following conditions and/or restrictions;

1 – This permit shall not be assigned or transferred without the written consent of the Town Highway Superintendent. The work authorized by this permit shall be performed under the supervision and to the satisfaction of the Highway Superintendent or his representative.

2 – Particular attention is called to the necessity of thoroughly compacting the back fill, which is required by the Highway Superintendent (no more than four [4] inch lifts with any motorized hand tamp). The back fill materials must match the prior layers and types of the materials dug out exactly.

3 – The Highway Superintendent shall be given one week's notice by said applicant of the date when they intend to begin the work authorized by this permit and prompt notice shall be given of the work's completion. The work will start on (date) _____ and be done by _____.

4 – The applicant hereby agrees to hold the Town harmless on account of damages of any kind which may arise during the progress of the work authorized by this permit or by reason thereof.

5 – Applicant certifies all persons concerned with actual work under this permit are duly covered by Worker's Compensation Insurance and the Town shall be held harmless on account thereof.

6 – The Highway Superintendent reserves the right to, at any time, revoke or annul this permit, should the applicant fail to comply with the terms and conditions which are granted by this permit.

7 – The applicant agrees to pay all necessary expenses incident to supervision and inspection by reason of the granting of such permit as certified by the Highway Superintendent. Such payment to be made within ten (10) days from the rendering of the certified account.

8 – The applicant shall submit a detailed plan with a description of the proposed construction.

9 – The applicant shall erect and maintain suitable guard rails or barricades around all trenches while work is in progress for the protection of the public, and they shall be suitably lighted by amber lights at night. The work shall be carried on in such manner that not more than one (1) hundred feet of trench in earth remains open at the end of the day's work. Traffic will be maintained by the applicant on the section of highway while the work is in progress until its completion. All New York State Department of Transportation type signs for a Work Zone shall be installed and maintained continually during the work. All signs will be in compliance with the New York State Manual of Uniform Traffic Control Devices (MUTCD). The location of all signs and types of signs shall be noted on the applicants map.

10 – It is understood that should future changes in the highway construction or use make necessary changes in the proposed work covered by this application and permit, the applicant shall, on reasonable notice from the Highway Superintendent, make such necessary changes at his own expense within the time as specified in the notice.

11 – The applicant will be responsible for the notification to all utilities by the UFPO organization as to his work and marking of all utilities.

12 – It is agreed by the applicant that any injury or disturbance of any part of the roadway system or adjoining property owners which may occur hereafter by reason of the work being done by this permit shall be repaired at the expense of the applicant and to the satisfaction of the Highway Superintendent.

13 – The applicant is required to carry a minimum one million dollar (\$1,000,000) Liability Insurance Coverage for the three (3) months prior to start of the work, during the work, and for twelve (12) months after this work is completed, and must supply irrevocable proof of coverage to the Town.

ADDITIONAL SPECIAL CONDITIONS

In consideration of granting this permit the undersigned accepts it subject to the conditions described and accepts full responsibility and liability for the work.
