After 34 years of dedicated and respected service as a Councilperson (1988-2022) and Deputy Supervisor (1990-2019), Ted Testa retired from his elected position in March 2022. My day starts with opening the office, which includes checking emails, voicemails and the drop box. Once the office is open a large majority of my day is spent at the counter helping the public. Depending on the time of year that consists of tax collection, water & sewer billing/collection, issuing dog licenses, disability parking permits, hunting/fishing licenses, vital records, and collecting fees for a variety of things such as building permits and fire inspections.

During the summer months the office is busy issuing marriage licenses. I enjoy seeing all the happy couples during the busy wedding season. July 1st marks the beginning of the second quarter water & sewer billing and on August 1st the sale of hunting licenses begins. When I am able to step away from the counter and spend some time at my desk I work on Town Board meeting minutes, Registrar/Vital Records filing, Planning & Zoning files, records management utilizing Laserfiche, and FOIL requests (Freedom of Information Law).

Highway Department Updates on Road Work & Streetlights

Road construction is underway in the Town. However, due to rising costs of fuel and blacktop the paving scheduled for this season is limited. Our crew has successfully completed the paving of Ely Road. Paving will commence on Stupke Road and Lime Hollow Road on June 20, 2022. Please watch out for our flaggers and road crew!

The Town's LED Streetlight replacement project is progressing. We have experienced delays due to the availability of product and shipping, Our apologies to all those who have been "in the dark" due to bulbs that have been out. We understand your concerns and are working with our subcontractor to have the bulbs replaced as soon as possible. We look forward to the completion of the project and cost savings to the Town.

Town Board Updates

- The moratorium on large scale solar projects has been lifted as the Town Board adopted 3 local laws concerning Solar effective May 4, 2022
 - Local Law No. 2 of 2022 Solar Energy System PILOT Law
 - Local Law No. 3 of 2022 Battery Energy Storage System Law
 - Local Law No. 4 of 2022 Amending the Town of Cortlandville's Zoning Code to Permit Solar Energy Systems in the Town of Cortlandville
- The Town has gone out to bid for Phase 2 of the Gutchess Lumber Sports Complex, which will include the construction of 2 new turf ball fields. Bids are due June 21, 2022.
- The Induction Ceremony for the 2021 and 2022 Town Hall of Fame will be held Friday, June 24, 2022. The recipients will be featured in the next Newsletter.

New Projects in the Town

Happy Summer everyone! As we find ourselves in the beginning of the swimming season, everyone needs to be aware of the safety issues surrounding pool and hot tub ownership. NYS Codes address these with mandatory permitting through the municipality to ensure proper installation of fences, alarms, removable ladders and other items specific to having structures that can hold water with depths in excess of two feet. It's important to know that even the collapsible pools sold by retailers are also subject to these regulations.

Please contact this office for more information as we need to be cognizant of the fact that drowning is a leading cause of death amongst children ages 1-4, second only to birth defects: Drowning Facts | Drowning Prevention | CDC

In other news, we're busy here in the Code Office with permits, plan reviews and inspections for everything from Property Violations, Fire and Safety, home renovations, additions, decks, garages and new homes, along with many expanding commercial projects for additions, remodels, and new buildings.

The Town of Cortlandville is excited to welcome some new businesses opening soon, including but not limited to: "Route 13 Discount Liquor and Wine" store (located behind Moe's) with the final finishing touches being completed at the time of writing this letter.

There's a new "Zoom Tan" almost ready for opening next to the Metro Mattress out in front at the Grand Union Plaza offering both UV and spray tan booths, so keep watching!

Also, in the same plaza a new "Pet Supplies Plus" store is currently being remodeled and, if I'm not mistaken, will become another welcome and much needed addition to the stores here in town!
