Please be advised that this office represents THE YOUNG MEN'S CHRISTIAN ASSOCIATION OF CORTLAND, N.Y. (hereinafter the YMCA) in regard to its application to subdivide the above referenced tax map parcel.

The YMCA has entered into a contract with Christopher Community, Inc. (hereinafter Christopher) for the purchase of a 1.593 ± acre parcel of land located on Homer Avenue. 


