Item – 3(i)

Although there is concern relative to water flowing down to the lower portion of Starr Road, it is believed that this can be mitigated by the approval of a Storm Water Management plan to be reviewed and approved by the Town Planning Board in connection with its complete review of the project.

Item 15 (d)(e)

While it is possible that by utilizing some type of lighting, there may be lightshining onto adjoining premises, the Planning Board can, as it has in the past, required the use of lighting which directs light downward rather than into the open space. This requirement will mitigate the shining light problem and the sky glow possibility to a degree that will reduce the effect of this potential problem.

Item 17 (a) (c)

The creation of a zoning classification as a Planned Unit Development will mitigate any inconsistency with zoning regulations. While the configuration of the development may be different from the existing area, the difference is not considered to be in "sharp contrast" with current surrounding land use patterns.
