WHEREAS, New York Tax Law Section 1262 allows municipalities to apply a portion of their Sales Tax against the Property Taxes levied upon real property in that municipality, and

WHEREAS, the Town of Cortlandville requests that the Cortland County Legislature apply \$0.00 (zero dollars and zero cents) of Sales Tax to be utilized in the reduction of the County Tax levied against Real Property, with the amount requested in this resolution divided by 4 and that \$0.00 quarterly amount be deducted from the County quarterly sales tax distribution as per agreements with the County related to Sales Tax Distribution, with any remaining funds available in Sales Tax payments paid to the Town of Cortlandville, and

BE IT FURTHER RESOLVED, that pursuant to New York Tax Law Section 1262, this resolution shall be effective commencing with calendar year 2019, and be it further

Dear Mr. Supervisor,

Thank you for your letter to Commissioner Seggos regarding your mining concerns. The Commissioner asked that I reply to you.

The mine you are referring to is owned by a limited liability corporation entitled "Rt. 13 Rocks." The mine has submitted an application to modify their sand and gravel mine permit both laterally and vertically. They propose to increase their current 66.8 acre life of mine to 78.3 acres. Vertical expansion is also proposed that includes excavating as much as 100 feet below the water table. This proposed action is subject to the State Environmental Quality Review Act (SEQR) and as you know, NYSDEC is lead agency.

There are significant natural resources in the area, which you note in your letter. The Town water supply well is located approximately 800 feet from the existing edge of the life of mine. The mine is within the wellhead protection area for the Cortlandville Lime Hollow supply well (the Lime Hollow Nature Center is a 430 acre nature preserve that includes unusual assemblage of marl ponds, a peat bog, and kame-and-kettle topography).

The Division of Environmental Permits (DEP), with technical input from Division of Mineral Resources (DMR), sent Rt. 13 Rocks a Notice of Incomplete Application in November 2017. The incomplete notice requested additional information about the sole source aquifer, potential groundwater and surface water impacts, information about the lime hollow well, noise, equipment refueling and potential spill best management practices and where these activities will take place, and other deficiencies with their initial application and mined land use plan.

Rt. 13 Rocks submitted additional information in March 2018. DMR reviewed the additional information and together with DEP, has deemed the application technically complete. The application is not officially complete until SEQR is resolved. The next step is for DEP to formulate a determination of significance, based on the information within the application. If the determination is a negative declaration, then a 30-day public comment period will be required. If the determination is a positive declaration, an

Environmental Impact Statement is required and the applicant must submit a Draft Environmental Impact Statement (DEIS) for review and comment.

Regardless of the determination, there will be ample opportunity for the Town and public to provide comments on the findings. Thank you very much for clearly outlining your position on this project.


