TERRACE ROAD WELL WATER MAIN DESIGN

Sealed bids will be received by the **Town of Cortlandville Town Clerk's Office at 3577 Terrace Road, Cortland, NY 13045** until **10:00 a.m., February 1, 2019**, at which time they will be publicly opened and read.

The work site is located on the undeveloped portion of parcel located at 3577 Terrace Road, which is adjacent to the Terrace Road well site and is owned by the Town of Cortlandville (corner of Terrace Road and McLean Road).

The work includes providing all labor, materials, machinery, tools, equipment and other means of construction necessary and incidental to the completion the work shown on the Drawings and described in these Specifications including, but not necessarily limited to, the following: installation of a 350-linear-foot 24-inch water main loop to lengthen the route of the public water system at the Terrace Road well site; erosion and sediment control; and complete site restoration.

Drawings and Specifications may be examined at the Town of Cortlandville Town Hall, 3577 Terrace Road, Cortland, New York 13045.

Complete sets of the Drawings, Specifications, and Bid Forms may be obtained from the Town of Cortlandville Town Hall, 3577 Terrace Road, Cortland, New York 13045 (Town Clerk's Office), in accordance with the Instructions to Bidders. Contract Documents will be provided electronically on a compact disc (CD) in PDF format and may be obtained at no cost. Contractors that obtain Contract Documents from a source other than the Issuing Office must notify the Issuing Office in order to be placed on the official Plan Holders List, receive Addenda, and other Bid correspondence. Bids received from Contractors other than those on the official Plan Holders List may not be accepted.

All bids must be made on the official Bid Form or an exact copy by reproduction thereof and enclosed in a sealed envelope. This is a lump sum bid as described in the Instructions to Bidders. No Bidder may withdraw his bid within forty-five calendar days after the actual date of the opening thereof. Each bid must be accompanied by a bid security in the amount of five percent of the base bid in accordance with the Instructions to Bidders.

The successful Bidder will be required to furnish construction performance and payment bonds in the full amount of the contract price.

The successful bidder will be required to comply with all provisions of the Federal Government Equal Employment Opportunity clauses issued by the Secretary of Labor on May 21, 1968 and published in the Federal Register (41CFR Part 60-1, 33 F.2 7804).
