Thorpe Municipal Building, 3577 Terrace Road, in the Town of Cortlandville, New York, to consider the following applications pursuant to the 1986 Zoning Law:

- 1. In the matter of the application of Gutchess Lumber for property located on 3599 NYS Route 281, Tax Map No. 95.12-01-13.000, for a variance in the terms and conditions of Article XVIII, Section 178-112, Table 1, to allow for a building mounted sign to be illuminated.
- 2. In the matter of the application of Bobbie Fox, for property located at the 1608 Oakcrest Street, Tax Map No. 96.36-01-10.000, for a variance in the terms and conditions of Article V, Section 178-21A(1) Bulk Regulations, to allow for a side yard less than allowed.

PUBLIC HEARING #1

Gutchess Lumber Co., Inc., Applicant/Reputed Owner - 3599 NYS Route 281 - TM #95.12-01-13.000 - Illumination of Building-Mounted Sign

Chairman Plew announced that he had no questions pertaining to this request for an area variance. He then recognized Scott Whitmore, representing the applicant who was seeking a variance to backlight a building-mounted sign as shown on the drawing/photos accompanying the application. The oval sign would face Route 281. Member Lenore LeFevre asked if the sign was going to be backlit for 24 hours; they did not intend to do this. Member John Finn advised that the Board usually limits the illumination of signs, e.g., turned off at 10 a.m. Mr. Whitmore

stated that they would do whatever the Board requested. He also added that they plan on removing the "old post" that used to be there.

Chairman Plew asked if there was anyone present who wished to speak regarding the requested variance; there was no one.

With everyone heard who wished to be heard, Chairman Plew closed the Public Hearing at 6:49 p.m.

PUBLIC HEARING #2

Bobbie C. Fox, Applicant/Reputed Owner - 1608 Oakcrest Street - TM #96.36-01-10.000 - Side Yard Less Than Allowed

Chairman Plew recognized the applicant who was seeking an area variance to construct a 12 ft. by 24 ft. carport on her property, as shown on the drawing accompanying the application. Ms. Fox stated she could not locate the proposed carport back on her lot any farther, to conform to the setback requirements, because of the location of the septic tank/leach field. The setback requirement from the side is 9 feet, and there's 5 feet as proposed. She stated that the adjacent neighbor, Mr. Henry, had reviewed what she wanted to do and had no problem with it.

Chairman Plew asked if there was anyone present who wished to comment on the proposed variance; there were none.

With everyone heard who wished to be heard, Chairman Plew closed the Public Hearing at 6:41 p.m.
